

SANITARIAN REGISTRATION EXAMINATION

DATES AND REGISTRATION

The State Board of Sanitarian Registration will administer the PES examination on the following dates in central Ohio.

October 20, 2005 10 AM - - Deadline for registration - September 15, 2005

March 2006 – Date to be determined

July 2006 – Date to be determined

Applicants for examination must be registered as sanitarians-in-training, or approved to take the examination by the Board through the submission and approval of an application for registered sanitarian. The appropriate application for registered sanitarian must be submitted at least ten days prior to the Board meeting immediately preceding the examination date.

The Board must receive the completed application form for examination and the appropriate fee by the registration deadline. There are no exceptions for admittance to the examination after the registration deadline.

The attached completed application form for the October 20, 2005 examination and the appropriate fee must be received by the State Board of Sanitarian Registration no later than September 15, 2005. Confirmations are mailed approximately 3 weeks prior to the examination date.

SPECIAL ACCOMMODATIONS

The State Board of Sanitarian Registration provides reasonable and appropriate accommodations in accordance with the *Americans with Disabilities Act* (ADA) for individuals with disabilities who demonstrate a need for special testing accommodations.

The requested accommodations must be supported by documentation from a professional who is licensed to diagnose the disability and include:

- Statement of the diagnosed disability.
- An explanation of the special accommodations recommended, including an explanation of why these accommodations or devices are needed and how they will reduce the impact of the identified disability.
- Information regarding the license or certification and area of specialization of the licensed professional

Requests for special testing accommodations and supporting documentation must be submitted to the Board by the examination registration deadline.
